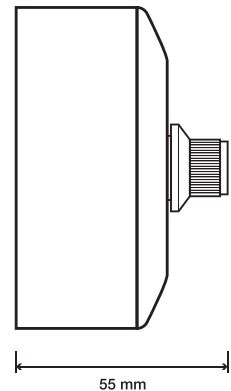

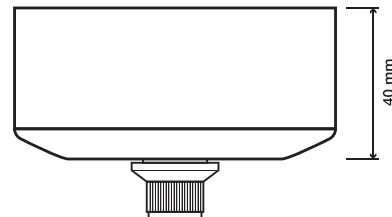
Front View



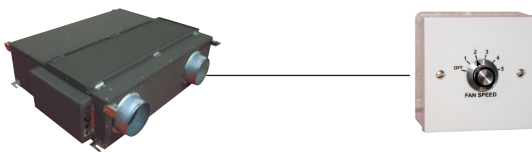
Side View
