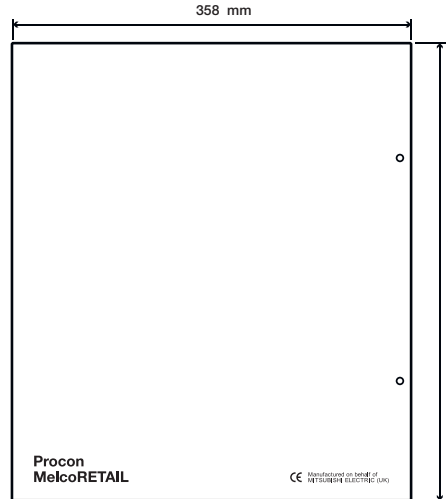

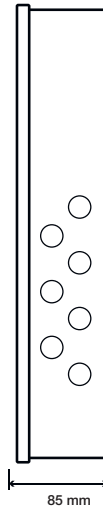

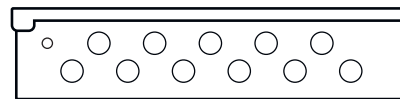
Front View
