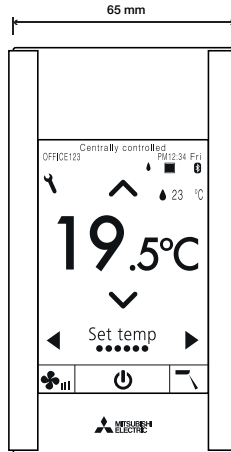

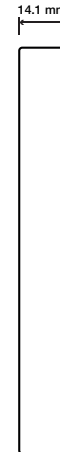

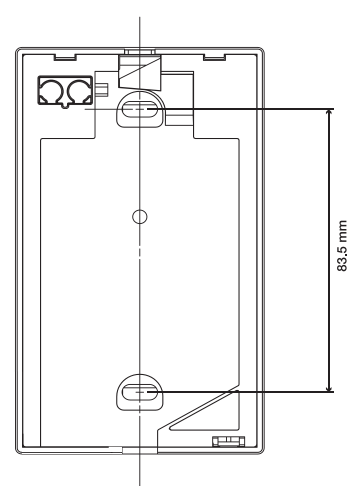
Front View



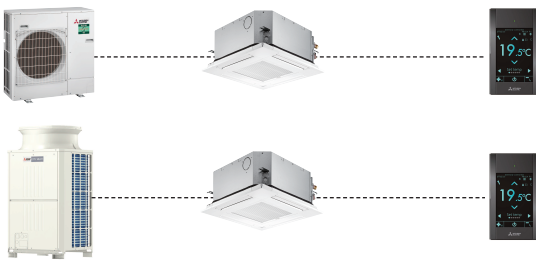
Side View
