

EXAMPLE:



One air handling unit controller is required per heat exchanger. If using more than one air handling unit controller on a single AHU, there are two options:

- Connect 1 x PAC-IF013B-E unit per heat exchanger these will operate as separate circuits with a controller on each which is included.
- Connect 1 x PAC-IF013B-E for the first heat exchanger, then up to 5 additional slave PAC-SIF013B-E units. The included controller with the PAC-IF013B-E will additionally control the slave units
