

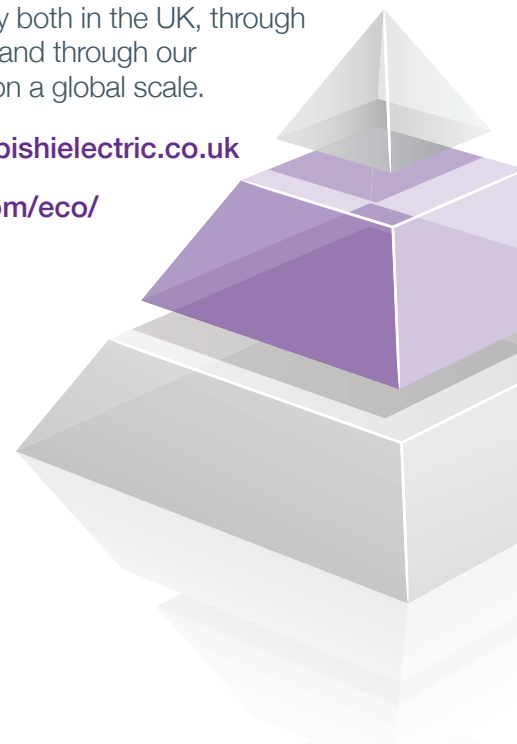
Energy Efficient, Recycling of Air Conditioning & Photovoltaics

Effective Recycling of Air Conditioning and PV

For a more sustainable future

The UK's Waste Electrical and Electronic Equipment Directive (WEEE) aims to reduce the amount of electrical and electronic equipment being produced by encouraging manufacturers to re-use, recycle and recover.

However, this directive does not currently cover air conditioning or photovoltaic systems. That said, with energy efficiency and environmental considerations at the core of our business, Mitsubishi Electric recognises the importance of effective recycling of such equipment at the end of its useful life. We have therefore developed our own recycling scheme in conjunction with reputable recycling partner, Overton Recycling. Working with Overton, we've developed an end of life recycling system for all air conditioning units and the PC Cycle for the recycling of photovoltaic panels.

Overton Recycling can also accept returned systems complete with refrigerant provided it is pumped back to the outdoor unit.
